Stock audit of banks is an important aspect of the overall audit of a bank's operations. It involves physical verification and valuation of the bank's physical stock of securities and other financial instruments held in its custody. Here are the key steps involved in conducting a stock audit of a bank:







4. When you started your career, What was your ambitions, what were your plans for the next 10 Yrs, Were you able to achieve it? If not what were your further steps?



ALL ABOUT GST AMNESTY SCHEME

THE CENTRAL GOVERNMENT HAS ISSUED FOLLOWING NOTIFICATIONS GIVING EFFECT TO PROPOSALS OF 49TH GST COUNCIL MEETING THAT ALSO INCLUDES AMNESTY SCHEMES.



Notification No. 02/2023 - C.T. dated 31.03.2023

Late fees in case of FORM GSTR-4 for July'2017 to quarters from March'2019 or F.Y. 2019-20 to FY 2021-22 has been waived completely in case of NIL returns and reduced to Rs 500/in other cases provided the said returns filed between 01.04.2023 are 30.06.2023.

Notification No. 03/2023 - C.T. dated 2. 31.03.2023

Registered persons whose registration have been cancelled on or before 31.12.2022 due to non-filing of returns may apply for revocation of cancellation up to 30.06.2023 only after furnishing the returns due up to effective date of cancellation the registration and payment of any amount due as tax, interest, penalty and late fee.

GSTR-4 Amnesty Scheme

for pending returns from July 2017 - Mar 2022









It has also been provided that no further extension of time period for filing application for revocation of cancellation of registration shall be available in such cases.

Further it has also been clarified that this Amnesty Scheme shall also be available to the persons whose appeal against the order of cancellation of registration or the order rejecting application for revocation of cancellation of registration under Section 107 has been rejected on the ground limitation of appeal under Section 107.

3. Notification No. 04/2023 - C.T. & Notification No. 05/2023 - C.T. both dated 31.03.2023

Combined reading of both the aforesaid Notification concludes that Biometric-based Aadhaar authentication and taking photograph of the applicant along with the verification of the original copy of the documents to be uploaded with the application in FORM GST REG-01 through one of the Notified Facilitation Centers is applicable only to the State of Gujarat.

The same shall be deemed to have come into force from the 26.12.2022.

4. Notification No. 06/2023 - C.T. dated 31.03.2023

Registered persons assessed u/s 62 of the CGST/SGST Acts, 2017 (i.e., Assessment of non-filers of returns) on or before 28.02.2023 and who have failed to furnish a valid return within a period of 30 days from date of service of assessment order can furnish returns on or before 30.06.2023 with payment of applicable interest & late fees. Assessment u/s62 shall be deemed to have been withdrawn.



Notification No. 07/2023 - C.T. dated 31.03.2023 5.

Annual returns in Form GSTR 9 for F.Y. 2017-18, 2018-19, 2019-20, 2020-21 or 2021-22 can be filed between 01.04.2023 to 30.06.2023 with a capping of late fees at Rs. 20,000/- (i.e., Rs. 10,000/- under respective head of CGST & SGST each).

Late fees rationalized for Annual Returns for the FY 2022-23 onwards based on the turnover of the registered persons. The same has been tabulated below:

S.N	Class of Registered Persons	Amount
1.	Aggregate Annual Turnover up to Rs. 5 Crores	Rs.50 per day (i.e., Rs.25 CGST & Rs.25 SGST) subject to maximum of 0.04% (i.e., 0.02% CGST & 0.02% SGST) of the turnover for the relevant FY in the State or Union.
2.	Aggregate Annual Turnover exceeding Rs. 5 Crores but up to Rs. 20 Crores	Rs.100 per day (i.e., Rs.50 CGST & Rs.50 SGST) subject to maximum of 0.04% (i.e., 0.02% CGST & 0.02% SGST) of the turnover for the relevant FY in the State or Union.
3.	Aggregate Annual Turnover exceeding Rs. 20 Crores	Rs.200 per day (i.e., Rs.100 CGST & Rs.100 SGST) maximum of 0.5% (i.e.,0.25% CGST & 0.25% SGST) of the turnover for the relevant FY in the State or Union





6. Notification No. 08/2023 - C.T. dated 31.03.2023

An amnesty scheme has been provided to the persons who have failed to furnish Final Return in FORM GSTR-10 within due date but furnish the same between 01.04.2023 to 30.06.2023. The late fees payable in such cases shall be restricted to Rs. 1,000/- (i.e., Rs.500/- under respective head of CGST & SGST each).

7. Notification No. 09/2023 - C.T. dated 31.03.2023

Limitation for issuing show cause notice u/s 73 of the Act for recovery of tax not paid or short paid or of ITC wrongly availed or utilized extended as follows:

1	FY 2017-18	31.12.2023
2	FY 2018-19	31.03.2024
3	FY 2019-20	30.06.2024


